2020/1 - The Minutes of the meeting held on Wednesday 21st November 2019 were **APPROVED**

2020/2 - The Neighbourhood Planning Champion attended the meeting to find out more from the Steering Group about the work done on the plan so far and to discuss how he could assist in progressing it. He explained that the role of Planning Champions was to advise and guide, rather than undertake the work of developing and writing the plan, but he could suggest a consultancy to take on specific tasks. The first action, however, he said would be for him to review the evidence that the Steering Group has gathered. Although he had seen the policies, he hadn't seen the evidence of data and research that is needed to underpin the policies. Once he can review all the documents that the Steering Group is confident about including as evidence, he can then advise on what further work is needed.

2020/3 - It was agreed to hold another meeting on Thursday 16th February for the Steering Group to review the evidence it has. This will be at the Parish Pavilion at 7pm.

2020/4 - A provisional date for a second meeting with the Neighbourhood Planning Champion, subject to him having seen the evidence requested, was set for Wednesday 12th February, again at the Parish Pavilion.
